ARCHIVES

The Archives Subcommittee met four times during the past year. It also hosted the first ever Archives Seminar in the Park Inn Hotel in September. It has been a busy year for the Archives Sub Committee and some of the main topics of discussion are described below.

The Borthwick Institute Cataloguing and Digitisation Project: Work is continuing apace on this project. James Neill the Archivist at the Borthwick Institute has been keeping us fully updated on progress. He is nearly halfway through the cataloguing process and plans to finish this part of the project during this year. He also plans to complete repackaging of the Archives currently stored at the Borthwick. This will ensure that they are all stored in optimum archival conditions.

James will continue to keep us fully updated on progress.

The 75th **Anniversary Publication Working Group:** The Working Group met four times during the last year. About half of the 16 Regions have produced material for the group to look at. It is hoped that the remaining Regions will send in their contributions by the end of June this year (2020) so that the group has an idea of what the Publication will look like. It is also hoped that Trustees will have produced a short history of their Disciplines by the same date.

The Archivist Network: The first ever Archives Seminar took place in September at the Park Inn Hotel. It was well attended and the discussions were lively and informative. Presentations were given on the following: Preservation and Conservation, The Borthwick Cataloguing Project, The Kelvingrove Event, The Magical History Tour and the Anniversary Publication Working Group. This was followed by a session on improving support to the Archivist Network. Everyone was split into smaller groups to discuss this and then everyone reconvened to list the findings of each group. The subcommittee came away with much food for thought and have started to implement ways in which to enhance and improve communication with the Network. These include circulating reports received from Archivists to the whole network and sending out bullet point summaries of subcommittee meetings. The subcommittee are also in the process of discussing the suggestion of a Starter Pack for new Archivists. It is also hoped that the policy for access to the Archives will be revised in light of the Borthwick Project progress and the Data Protection Legislation.

The Archives Subcommittee: This report would not be complete without expressing my sincerest gratitude to this hardworking and extremely supportive subcommittee. Harry R has settled into his role as Fellowship Archivist and will be taking a greater role as time progresses. Martin B and John C are continuing to play an active role and we welcomed back Nick H and Joe H to the Sub Committee this year. Joanna B and Jim S will be leaving us during the coming year and I express my gratitude to them for all their support and hard work for the subcommittee.

I must also express my sincere debt of gratitude to Jenny, Ranjan, Emma and all the Staff at GSO for all their invaluable support and help during this past year.

Archives is an extremely interesting and rewarding discipline which continues to go from strength to strength thanks to the unwavering commitment, hard work and support of the Archivist Network throughout our Fellowship, the Subcommittee and the GSO staff.

Armed Services

My thanks to the Armed Services Sub Committee for all their sterling work, we have had a busy year and continue to let the upper ranks know we are available.

We were invited to the Defence Medical Service Whittington Barracks Health Fair. Over 500 staff and trainees attended the event.

Attendance at the Fit4Life health fair at RAF Cosford with the ASLOs from 2 Intergroups. We set up our stand and popup banners, and spent the day speaking to staff, trainees and other stand holders and handed out many leaflets and pamphlets. There were over 2000 visitors on the day.

We were invited to the Health Fair at RAF Cosford 15th. We were also invited by The Forces Deputy Practice Manager at the Birmingham Medical Facility at the Queen Elizabeth Hospital to give a talk to his staff. After a short talk about there was a question and answering session where about 20 staff including the camp Doctor enthusiastically asked questions.

Meetings with the area manager at the Royal British Legion, contact has been made with the Birmingham Council. Councils have a designated person looking after ex-military personal these are being sought all over GB.

There is regular attendance at the Tri Service Facility in Stoke on Trent making more contacts there.

Royal Forces Employment Agency (RFEA)

The RFEA is a nationwide government supported agency, helping veterans and their families in their transition to civilian life. They have lots of different initiatives and have cooperation with many other services and agencies – e.g. NHS England, Help for Hero's etc.

One particular project they run is "Project Nova" (National Organisation of Veterans Advocates). This has been especially set up to help veterans, or their family members, that are (or may become) subject to the criminal justice system, something for Criminal Justice and Probation to look at as well. Their experience has shown that most of those involved have problems with either alcohol or drugs — or both. Following an approach to their coordinator in Nottingham, they have made some referrals to AA with a limited amount of success.

There is also a new NHS service - NHS Transition, Intervention and Liaison (TIL) — a mental health service starting up in our area, I'll try to get in touch. They focus on people finding themselves with mental health issues upon leaving the forces.

One exciting outcome of opening up dialogue with RFEA, NOVA and SAFFA is Armed Services working with Employment as part of the Blue Light initiative as highlighted in the Annual Armed Services Liaison Meeting in February and the Employment Sub-committee meeting in March. The blue light initiative can be adopted by other disciplines for example a new pamphlet could be designed with the emphasis on the suffering Alcoholic with military background now in employment in the blue light services.

To preserve anonymity and to comply with GDPR, we continue to offer generic email addresses for all posts at Intergroup and Region levels. To avoid delays with their issue, please ensure that the Confidential Directory is kept up to date.

Employment

The presentations given in North East Region and North West Region also at Intergroups to inform the Intergroups of the necessity of an Employment Liaison Officer. We have also been liaising with Public Information for Public Health England.

We are continuing to put out our newsletter Hello ELO it is on the website under Employment.

Our Terms of Reference (TOR) have been updated and are on the website.

Professional Awareness Day was attended, liaison with GCHQ again and several other contacts which includes the Samaritans and the Deputy Police & Crime Commissioner.

Intergroup ELOs are making successful contacts with large employers in their areas Devon Central, West Dorset and Poole & District Intergroups and have visited an Employment event organized by Poole & District, Bournemouth and West Dorset and gave an address on the ELO role.

Scotland still contacting the Regional Chairs in the 4 regions that have no ELO in post. Highlands & Islands really struggling to fill vacant posts. East of Scotland, Scotia and Glasgow still no interest shown in the post.

London Region North has a committee encompassing Regional ELO, HLO and PI officers which the SC member for Employment sits in and they develop big ticket items such as underground posters campaign, radio advert campaigns etc.

The turnout for the Seminar was good there were 37 people who turned up introductions around the room.

We had a seminar which was quite well attended, Sean N (Sub Committee member) gave a PowerPoint presentation which included some helpful points regarding PI committees and the walkabout of members and the

small chips that were handed out to the public, as well as Q & A workshops and the videos that are available on the website.

Our guest speaker was Ian L, he owned his own business and has employed many people over the years and he is also a member of our Fellowship. He gave us many insights and told of the approach that could be and told us of the many Health and Safety Policies he had to adhere to, he told us of the men he has had to fire also of the ones he has helped.

There was a Q & A and it was suggested to maybe look at Health and Safety regulations.

He suggested to add the 20 questions to the Employment Pack, also the consequential cost of drinking to the employer, he talked of having a toolbox to take to the employers.

I would just like to mention the Blue Light which spans two disciplines Armed Services and Employment which involves contact with the members of the Armed Forces who have finished their time and go into the Police, Ambulance And Fire Brigade, we have been in communication with them to let them know we are here and there has been a good response. Letters from Police and Ambulance, as yet no Fire Brigade communication, we hope for further communication.

Health

The Health Discipline of Alcoholics Anonymous, through its members of the Health Sub-Committee (HSC), continue to work closely with Intergroup and Regional Health Liaison Officers (I/RHLO`s) to carry the message at every opportunity to Healthcare and other Professional front line staff working with the still suffering alcoholic.

These include frontline staff within the NHS England & Wales, NHS Scotland, emergency "blue light" services, the judiciary, education, treatment centres alcohol forums, Parliamentarians, and the Clergy, and many relevant others.

OPEN MEETING WORKSHOPS

The Open Meeting Workshops (OMW) are a vitally important conduit through which we continue to carry the message to the widest audience of front-line staff. Numerous Universities now participate and value these meetings, including London St Georges, Surrey, Sussex, Brighton, Chester, Edinburgh and the University of the Highlands & Islands.

The OMW is adaptable and transferable. All that's required is a small space and a listening audience. Recently an OMW was presented in Highlands & Islands Region to a cluster of five health practices sharing their Practise Learning Time. The Health & PI awareness team facilitated the OMW and the multi-disciplined health professionals who attended represented a combined patient total in excess of 50,000 patients. One fifth of the population of the H & I's.

NHS ENGLAND, WALES & SCOTLAND

The HSC members are working at all levels from Policy development to implementation, working within local communities and within the respective NHS structures to carry the message wherever and whenever appropriate.

A member of the HSC, employed at a senior level within NHS England, identified an opportunity that would allow AAGB to co-operate with NHS England. Working closely and in conjunction with the General Secretary, they negotiated and implemented a Social Prescribing guiding strategy. This permits a local NHS community liaison nurse, who has identified an alcoholic patient who is seeking help, to contact a named person in GSO, who will in turn contact the relevant R/IHLO who will then reach out to carry the message to the still suffering alcoholic. At all times adhering to AA recommended Guidelines and Traditions.

When the lead doctor of addiction services in Glasgow Region tragically died last year, the I/RHLO's were concerned that the Hospital Responders Scheme (HRS) initiated and developed in co-operation would collapse. However, the addiction nursing team who were an integral part of the HRS immediately stepped in to reassure the I/RHLO's and hospital responders that they would continue to work together. This simple scheme commences with the addiction Nurse identifying a patient on the ward, who is willing to accept a visit from two AA's carrying the message. The nurse then telephones the Northern Service Office, whereby a member of staff consults the hospital responders list and within as short a period as possible two members of AA are sitting with the man/woman in the bed. In excess of two hundred and twenty visits have been made to date, contact is maintained and whenever possible, a patient is taken to an AA meeting within the hospital and on release.

A similar bedside visit scheme is in operation in Kings College Hospital, London. This scheme, which has been operating for six months is proving to be very successful. AA members are trained by the Hospital staff to meet the Kings College Hospital volunteering scheme requirements. The AA members then report to the Alcohol Liaison Team who will have identified male/s or female/s patient who have agreed to be visited by two AA members. One male and female member report every Tuesday, confirming to the Kings College Hospital Alcohol Liaison staff team Alcoholics Anonymous `s continued commitment and dependability to carry the message to the man or woman in the bed.

Ysbyty Gwynedd Hospital in Bangor Wales Bangor opened a meeting mid 2019 and the meeting is going from strength to strength. A core group of 30 members attend and patients and family members come down from the wards to the meeting. The family members are given Literature and directed to the appropriate Fellowship whilst members are welcomed to the meeting.

A presentation delivered at the Matrons' meeting, built relationships with staff. The members now visit the wards and are trusted and appreciated by the staff. A monthly information table has proved very successful and this is rotated around different locations within the hospital. The Group are developing a small collection of personal stories from members who began their recovery journey, occasionally in the very same bed. Use of the Hospital radio to announce the meeting has also proved successful.

Conferences & Events

AA is invited to many Conferences and events across GB and GSO staff, HSC members, I/RHLO's etc attended 22 health related events this past year including:

The Nursing in Practice and Pulse (for GPS).
The very prestigious MIMS Learning Live Expo in London]
The NICE Annual Convention in Manchester
The Annual MCA Symposium in London
The Annual International Mental Health Conference.

Along with two HSC members I travelled to Belfast, to attend and support two members from CER Region, to carry the message to the Delegates of The Annual International Conference on Mental Health. This was an excellent opportunity to represent AA within the various workshops etc. A well-stocked AA Literature table attracted many multi National Professionals, who were very interested in AA, its history and efficacy. It was also an excellent opportunity to enhance our Fellowship and friendship with the Belfast Region members of AA Ireland.

The Health discipline will continue to represent AAGB at these events whenever appropriate. Dr Eric Carlin, Non Alcoholic Trustee (NAT) on the General Service Board of AAGB will deliver a presentation at The MCA Symposium in London in November 2020.

Dr Mani Mendikhani who for some time was our lone NAT Trustee on the GSO AAGB is co-chair of the HSC. Mani is frequently called upon to represents the Fellowship at numerous events. He is the knowledgeable, supportive and steady voice of Alcoholics Anonymous and the Health Sub Committee at the public level.

Both Eric and Mani were an integral part of the Health Seminar held in March 2020. This positive event was well attended and if you are interested in carrying the message to Healthcare or other professionals. Please contact your I/RHLO. YOUR FELLOWSHIP NEEDS YOU!

Literature

I have the privilege in presenting this report on behalf of the Literature Sub Committee. It has been a pleasure serving Alcoholics Anonymous and I am now presenting my final report to the Fellowship, as I rotate out of this position. The following pieces of literature are for consideration by Conference 2020. Some background information has been provided to give an indication how the new and revised literature came about.

Revised Literature

1. Carrying the AA Message to the Hard of Hearing pamphlet

A new logo replaces the existing one on the original pamphlet and the text has been slightly revised. These changes came as the result of feedback from a member of the deaf and hard of hearing community.

New Literature

2. Growing in Service

Background Information - Growing in Service Pamphlet for Submission to Conference 2020

The Literature Sub Committee produced the proposed new pamphlet, entitled "Growing into Service" which came as the result of reviewing the existing 'red' pamphlet of the same name.

The Literature Sub Committee proposes that this new pamphlet replaces the current Growing into Service pamphlet for the following reason:

The proposed pamphlet provides a good reflection of the various opportunities that service bring throughout the AA Service Structure, in a way that is interesting and visually attractive

We feel that the new proposed piece of literature could more effectively encourage more members to get involved in service, which assists them with practical advice, and offers inspiration, thus making the current pamphlet redundant.

3. 15 Points Pamphlet – from the 12th Step Starter Pack

At Conference 2019, Committee Two recommended that the pamphlet be revised to emphasise our Three Legacies of Recovery, Unity and Service. In line with the committee recommendations the Literature Sub Committee has revised the pamphlet whilst considering the following points:

- a. The focus of the pamphlet is for the newcomer. Its purpose is to share some coping methods for staying away from the first drink in early recovery
- b. The revisions ensure that the message is consistent with the principles of our recovery programme as set out in the Big Book "Alcoholics Anonymous"

PRISONS

There were various actions happening in the Prisons discipline not least the state of the Prison System.

Staff got so sick of understaffing and underfunding that they'd had enough and were leaving the service, it didn't help that they had a change of Minister so often, so it's no wonder AA was getting problems with meetings running and clearance etc.

Over the year Maxine and myself attended inside government meetings getting updated and making contacts for future reference. It would be a good place for AA to give a presentation as there are many delegates representing PHE and the Ministry of Justice as well as other agencies like ourselves i.e. Mutual Aid.

The problems with vetting and clearance seem to be petering out although you still get the odd one now and again and it seems to be inexperienced staff or forms not being filled in right, which is when we say you should use standard plus forms.

The Sub-Committees would like a National Chit for meetings and we are engaging in talks just now to see if this feasible.

As you all know we had a Seminar in June 2019 and it was very well attended and very informative, all be it was mostly Scottish orientated, it went down well with Liaison Officers and Visitors. We did ask representatives from England and Wales but most were too busy or on holidays.

Liaison officers will be glad to know that the Board have agreed to re-instate Zonal Meetings this year and they are as follows:

Warrington 31st May, Cambridge 26th July, Stirling 27th September and Bristol 25th October.

Hoping to see you all there at one or the other area meetings, old friends and new friends.

Maxine and myself attended the Bulgarian 2nd Seminar who kindly invited us as CJS Representatives for AA GB. We were very surprised by the amount of visitors that were let into the prison meeting we visited, there was about 30 to 50, and there was strong unity and good shares.

We then went on to the Seminar where there were presentations from psychiatrists and therapists, as well as prison authorities. We were asked many questions about prison and guidelines in GB which was very uplifting and would thank Bulgaria AA for asking us and their hospitality.

The Probation Service is now back into 11 areas with 11 CEOs in charge of each area, with shorter sentences being given for less demeanours means there will be more people coming to AA for repeat alcohol induced crime and that is why we are talking about having a National Chit and we need more people doing service in Probation so, if you can help, please talk to your intergroup or region rep.

As you know most companies are being told to review their Safeguarding Policies and AA is no different and I am glad to say that AA is well ahead in that we set up a committee to look at setting up a Safeguarding Policy and this includes Prisons & Probation.

Lastly, but not forgotten, is the Website and Manual which the Sub-Committee has been discussing for ages but it is all technical stuff and in saying that, not everyone is tech minded, so we have to strike a balance and don't forget we include everybody in AA, us as well, but it is time to see action in this and try to make an EASE OF ACCESS for all which includes New Officers so they don't feel alone or lost when they take up a new position.

PROBATION

There have been huge changes in the organisation of the probation service it will take considerable time to settle into its new format.

Our message to the alcoholics within the system is the same however. AA is the stable force which is not affected by governments and outside agencies. We may face new challenges in our service but will acclimatise to whatever the circumstances require.

We have welcomed new members to the subcommittee and are in the process of updating and improving our web presence. We are encouraging groups to implement the chit system and we have just had a National chit approved which will be available from GSO.

We have a good relationship with National Health England who work in similar fields. We had a well attended Seminar last year at York and have zonal meetings planned for this year.

I was invited alongside Pat, our Trustee for prisons, to attend a prison meeting and weekend seminar in Bulgaria last November. Although their service structure is not fully operational they have great enthusiasm for prison service and we exchanged many ideas.

We are fortunate that one of our newest NATS has extensive experience in the penal system and has expressed a willingness to use his contacts to benefit our cause. We hope to continue to expand our knowledge and increase our list of contacts in 2020.

Public Information

Public Information (PI) operates through AA members, Groups, Intergroup, Regions and the General Service Board and its Public Information Sub Committee. Our Non Alcoholic Trustees assist with carrying the message to every area of the wider Community. PI is often the first contact the public have with the fellowship.

Media Events

During the year we have released eight articles for the press on our Public Information section of the website including "Dying for a Drink ", The 80th Anniversary of AA, Accrington Stanley under 18 squad and events at the Parliaments of Holyrood, Westminster and the Welsh Assembly in Cardiff. We continue to subscribe to a media response organisation and also follow up on many media requests forwarded to us by the General Service Office.

During Alcohol Awareness month our East Lancashire Intergroup PI team were very successful on November 13th in organising with Garry Scott of BBC Radio Lancaster a three hour "phone in". This was with our Non Alcoholic Trustee Mani and seven members of the fellowship, all telling their real life stories on air and choosing their favourite music. This must have been a first for a PI Intergroup PI team.

We encourage all our PI groups to adhere to our AA traditions asking the Media to respect individual member's anonymity especially when dealing with the press, radio and TV.

Advertising Campaigns

London's West End intergroup ran a London bus poster campaign in November as did West Dorset Intergroup.

Newcastle Intergroup likewise ran a Poster Campaign on their Public Transport System in November.

P.I. Video for Professionals

The new AA videos were approved by Conference in April of 2018 and these have been made available to members and professionals throughout 2019. The P.I. video has been well received and is available with videos of the other AA disciplines for Health, Employment, Armed Services, Employment, Prison and Probation on the Alcoholics Anonymous Great Britain website under latest news – click on videos for Professionals.

P.I.Sub Committee

We met four times during 2019. We continue to encourage Intergroup P.I. Initiatives with events for professionals working with both their local press and regional television. We were delighted to welcome Eric Carlin our Non Alcoholic Board to the subcommittee in November and he has already made a valuable contribution on our discussion with the Public Health England substance use committee.

We held a Regional PI Officers' Meeting in York in September which was well attended. In addition to the annual Regional PILO meeting we held the third P.I. Awareness Event in Glasgow in March for the six Scottish Regions. This was well attended by both regional and intergroup PI liaison Officers There were three of these events over twelve months which serve to motivate our P.I. teams and giving them a wealth of information and experience. A new challenge for 2020 and to 2021 is to prepare a PI display at the 75th 2022 Anniversary Convention and to assist with media events and information for the 75th Convention

Continental European Forum December 2019

There was a PI presentation at this Regional forum last December which was well received at their Assembly in Brussels. Encouragement was given to the region to support Intergroup activities; thinking about the geographical challenges that the many PI groups have. The presentation encompassed much of the material given at the UK Regional Awareness Events and our P.I. resources memory sticks were in great demand. A most interesting and enthusiastic weekend for the PI trustee.

P.I. Service News

This publication is circulated throughout the fellowship at the beginning of each month. Any member can request a copy of the P.I. Service news from his P.I. team or intergroup secretary and by requesting to be added to GSO's circulation list. PISN shares current PI experiences, and acts as an archive for reference; It is distributed by email. We are most grateful to our editor who continues to produce this excellent publication on a monthly basis. Please keep your local P.I. news flowing and good luck with all your primary purpose work in 2019.

Telephones

Terms of Reference for the National Telephone Sub-committee (NTSC)

To maintain the existing telephone system, to enable the suffering alcoholic access to a local contact through a single national telephone number, in a manner which is efficient, effective and economic.

To keep the use and cost of the system under constant review.

To be responsible for all changes to the system and to liaise with the system providers following consultation with Regions.

To investigate any new technology which may be beneficial to the Fellowship's telephone service.

To keep constant review of the facilities offered by other service providers.


The committee is a sub-committee of the Board and will be chaired by the Trustee with responsibility for the telephone service. Membership will normally consist of a minimum of four and a maximum of eight members drawn from participating Regions, who are suitably experienced to participate in committee functions. Where possible this will recognise geographical spread.

Membership of the Committee will be for a period of four years, allowing one year for sponsorship, thus the committee will be increased during sponsorship periods.

The subcommittee has continued in its work, supporting Regional Telephone Liaison Officers (RTLOs) and TLOs, especially in the time of transition from analogue to digital service. Most local Helplines are now fully digital, and the consensus is that it makes life easier for RTLOs to manage. A major restructuring of the Scottish helplines has now completed, and the new system successfully went live in November.

Telephone administrators (i.e. RTLOs) and responders can now make good use of the various features of the new AA website. In addition, the 'where to find' now has details of local telephone numbers which should make it more likely that anyone ringing will be put through to a responder in their locality.

In the final quarter of 2019, there were according to BT statistics 22,134 calls – over 1,700 a week. These figures are in line with Q1 and Q2 of 2019 and at the same time lost calls, including Ring Tone No Reply calls (a caller phoning and no one picking up the phone) have also plateaued.



There are no accurate figures for how many of these calls are from the still suffering alcoholic. However, looking at those areas that log different types of calls, a reasonable estimate would be 600 still suffering alcoholics are phoning the helpline each week. It is worth pointing out that the majority of the RTNR calls were under 10 seconds giving little time for the responder to pick up.

The Helpline depends on the tens of RTLOs, the scores of TLOs, the hundreds of Telephone Responders, and the thousands of Twelve Steppers. The Service they all provide is essential, valuable, rewarding and is always in need of more people coming forward to be involved at all levels.

In August this year we have a Telephone seminar, to which all RTLOs and TLOs are invited and this during this event we will be looking at what we do and how we can do it better.

We are all responsible for passing the message to the suffering alcoholic.
