Breaches of copyright are apparent in many internet sites which in some way are related to Alcoholics Anonymous, whether a disclaimer is used or not. On-line versions of our literature appear, primarily the 'Big Book' in all 3 editions, (but other material in image or pdf format is also to be found). It has not been approved by any General Service Conference in this or any other country that an on-line version be produced. An audio file of the Big Book can also be found on the internet. The Fellowship has been determined (1978, 1986, 1989, 1992, 1993, 1995, 1997, 1998, 1999, 2000, Advisory Actions, AAWS) that there should be no change to the first 164 pages of the Big Book, does the General Service Conference in Great Britain and Continental European Region consider this form of publishing and breach of copyright acceptable?

Make recommendations and advisory actions bearing in mind copyright laws vary in different countries, but this form of media used for publishing is global.

Bill W. said (Warranty 2 of Concept 12), in his essays on The 12 Concepts for World Service, 'Next comes the question of whether A.A. as a whole should go in for what amounts to a money charity to individual newcomers and their sponsors-via the selling of our books at cost or less. Up to now we A.A.'s have strongly believed that money charity to the individual should not be a function of the A.A. groups or of A.A. as a whole. To illustrate: when a sponsor takes a new member in hand, he does not in the least expect that his group is going to pay the expenses he incurs while doing a Twelfth Step job. The sponsor may give his prospect a suit of clothes, may get him a job, or present him with an A.A. book. This sort of thing frequently happens, and it is fine that it does. But such charities are the responsibility of the sponsor and not of the A.A. group itself. If a sponsor cannot give or lend an A.A book, one can be found in the library. Many groups sell books on the installment plan. There is no scarcity of A.A. books; more than a half million are now in circulation. Hence there seems no really good reason why A.A. services should supply everybody with cheap books, including the large majority who can easily pay the going price. It appears to be altogether clear that our world services need those book dollars far more than the buyers do.

Some of us have another concern, and this is related to so-called book "profits." The fact that A.A-Headquarters and most of the groups sell books for more than they cost is thought to be spiritually bad. But is this sort of noncommercial book income really a profit after all? In my view, it is not. This net income to the groups and to A.A.'s General Services is actually the sum of a great many contributions which the book buyers make to the general welfare of Alcoholics Anonymous. The certain and continuous solvency of our world services rests squarely upon these contributions. Looked at in this way, our Reserve Fund is seen to be actually the aggregate of many small financial sacrifices made by the book buyers. This fund is not the property of private investors; it is wholly owned by A.A. itself.'

Surely this is a massive example of the sort of charity we should not be involved in.

These breaches of copyright must have an effect on the revenue raised through the sales of literature, and consequently the ability to fund other efforts in carrying the message around the World.

Our General Service Conference in 1998, approved the Guideline on Copyright and logos. We now see various symbols/logos similar to our registered mark being used by bodies both in and outside of our Service Structure, are we in danger of following exactly in the footsteps of America, where the proliferation of so many variations of the circle and triangle resulted in the decision that as it was not possible to maintain any integrity in the symbol, then no symbol could be used. There is a level of trust implied by the use of the logo, who can we trust when there are so many different logos purporting to be Alcoholics Anonymous. Perhaps it is a different 'branch of Alcoholics Anonymous', we are one Fellowship, with one message....

Tradition One (long form), Each member of Alcoholics Anonymous is but a small part of a great whole. A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows close afterward.

Tradition Four (long form) With respect to its own affairs, each A.A. group should be responsible to no other authority than its own conscience. But when its plans concern the welfare of neighboring groups also, those groups ought to be consulted. And no group, regional committee, or individual should ever take any action that might greatly affect A.A. as a whole without conferring with the trustees of the General Service Board. On such issues our common welfare is paramount.

Tradition Five (long form) Each Alcoholics Anonymous group ought to be a spiritual entity *having but one primary purpose* - that of carrying its message to the alcoholic who still suffers.

They are authorized by the groups to handle our overall public relations and they guarantee the integrity of our principal newspaper, the A.A. Grapevine. All such representatives are to be guided in the spirit of service, for true leaders in A.A. are but trusted and experienced servants of the whole. They derive no real authority from their titles; they do not govern. Universal respect is the key to their usefulness.

Tradition Ten (long form) No A.A. group or member should ever, in such a way as to implicate A.A., express any opinion on outside controversial issues - particularly those of politics, alcohol reform, or sectarian religion. The Alcoholics Anonymous groups oppose no one. Concerning such matters they can express no views whatever.

For many of us the Big Book is a vital tool of sobriety and it has been considered so ever since it was published (cf AA Comes of Age, p22). Last year, sales of the Big Book in Great Britain were about

6,500. This is a very low figure -an average of about two books per group *per year*. At £8.20 the Big Book is too expensive for many new members to buy. In the US the Big Book retails for, on average \$4.50 per book, roughly one third of the price here. Cheaper Big Books would mean more newcomers could afford it and so would stand a greater chance of staying sober.

One of the visitors told us the story of how when someone joined their group and was given group phone numbers all their houses were burgled.

Upon asking this question at our Intergroup we feel we were given an answer that was not quite suitable. The objection being that certain people used the number of the helpline to ask questions such as "Where is that group?", "Where is that dance?" etc. etc.

We feel that it is well overdue that the harassment of people who are still getting calls after various circumstances, not excluding death of an individual, should try to be rectified. Also do not forget the abuse factor. I have been subject to this personally and I can assure you it will not sway my decision to remove my phone number and install one or two of the many female members of my group.

May I also say that over the last thirty odd years I am no stranger to 12<sup>th</sup> stepping people and was very involved at an earlier time in our City when there were not many cars or telephones available. May I also reinforce that this concern is based on the knowledge of my dealings with many AA members, many on a one to one basis. Hope you can formulate this question for me as I feel it is so important.
